Chip Morgan, M.A., Senior Polygraph Instructor, and Investigator

Chip Morgan is a nationally recognized Polygraph Instructor, and Law Enforcement trainer and lecturer. Chip has been a featured speaker, primary instructor, guest lecturer and keynote speaker at numerous national training seminars and colleges throughout the world. Chip has an Associate of Arts in Criminal Justice Administration and a Bachelor of Science degree in International Security Management and Intelligence. He has qualified and testified as an expert in Idaho and California State Courts and the United States Federal Court system. Chip Morgan holds a Master's Certification from the Peace Officer Standards and Training Council and has been a certified Law Enforcement Instructor since 1980 and a Polygraph Science Instructor since 2010. Chip Morgan is a published author and recognized expert in the art of Interview and Interrogation.

Barbara Johnson, M.A., Supervisor, Pima County Adult Probation Department in Tucson,

Barbara is the unit supervisor and coordinator of the Sex Offender Program of the Pima County Superior Court Adult Probation Department in Tucson, Arizona, where she has devoted 25 years of her career to the community management of sexual abusers. She is dedicated to efforts advancing collaborative partnerships, while promoting community safety, and considers the most important of these relationships to be that which she and her team share with sex offender treatment providers, polygraph examiners and other identified stakeholders, understanding this team approach is critical in the development of treatment and supervision strategies.

Beth Hoel, Supervisor for Maricopa County Adult Probation Department

Supervisor in the Sex Offender Division of MCAPD that oversees the supervision of more than 3000 sex offenders in Maricopa County. Ms. Hoel has spent 23 years with MCAPD to include positions as a screener, Adult Probation Officer and Supervisor in the Presentence Investigations and Sex Offender Divisions. Currently her position as supervisor is in the Sex Offender Division where she has served for the last ten years. She leads a unit consisting of both Intensive and Standard Probation Officers who utilize the Offender Screening Tool (OST), the Field Reassessment Offender Screening Tool (FROST), the Static 99R, the Sex Offender Treatment Intervention and Progress Scale (SOTIPS) and the ACUTE to identify risk, needs and interventions.

Shane Neil, Supervisor for Maricopa County Adult Probation Department

Supervisor in the Sex Offender Division of MCAPD that oversees the supervision of more than 3000 sex offenders in Maricopa County. Mr. Neil has spent 19 years with MCAPD to include positions surveillance officer, probation officer and supervisor in both the Standard Field and Sex Offender Divisions. Currently his position as supervisor is in the Sex Offender Division where he has served for the last ten years. His unit consists of sex offender officers who serve the specialized Youthful Offender population and the Severely Mentally Ill in addition to our standard sex offender population.

Amanda Faust, M.A., Compliance Specialists with AZPOST

Mandy Faust is a retired Lieutenant from the Phoenix Police Department where she worked for over 20 years. She joined Arizona POST in August of 2019 as a compliance specialist and has recently been promoted to the Training Manager position.
