SPEAKER BIOS

Christopher Campbell

Chris has been in law enforcement since 2005 and has investigated sex crimes, homicides, and all other major crimes. In 2010, Chris joined the North Carolina State Bureau of Investigation (NCSBI) and has been a polygraph operator since 2012, conducting criminal and pre-employment testing. While being a polygraph operator, Chris was assigned to the NCSBI field as an agent/polygraph operator and spent time in the Computer Crimes Unit. Chris is currently assigned to the Behavioral Threat Assessment Unit within the NCSBI and is a lead instructor for the NCSBI Special Agent Academy Interrogation School. Chris holds a master's degree in Forensic Psychology and is currently pursuing his Doctorate.

Scott Naegele, MC, NCC, LPC

Prior to completing his master's degree, Scott worked in various capacities at a residential treatment center called the New Foundation. While at the New Foundation, between 1986 and 1990, Scott served as dorm counselor, lead dorm counselor, and while completing his master's degree at Arizona State University, as an aftercare counselor for client's discharged and returned to the community. Since completing his master's degree from Arizona State University in 1990 Scott's caseload has always included work with clients presenting with sexual behavior problems. Originally this work focused on youth with said issues in both residential and outpatient settings, including The New Foundation, CASA (Center Against Sexual Abuse), and The Devereux Center of Arizona. In 1995 Scott accepted the lead therapist position at Arizona Youth Associates (AYA), a residential program working exclusively with sexually abusive youth. Not long after beginning his tenure at AYA Scott was promoted to Clinical Director, a position he held for the next six years. During his time, while working at AYA, Scott grew increasingly interested in the task of risk assessment, using assessment protocols designed to more objectively evaluate risk with adolescent sexual abusers, and in turn to develop treatment paths that more specifically mirrored the risks and needs of the individual client rather than applying a "onesize fits-all mentality"; he remains committed to this task to this day. By late 2004, after working for a period of time for Pre-Hab of Arizona, currently known as A New Leaf, in the role of Director of Training, Scott began working fulltime at Family Transitions, an outpatient treatment program, where he worked with both young adult sexual offenders and their somewhat older counterparts. At approximately that same time he began doing more and more risk assessment work, seeking to add differentiation and a need for drawing distinctions between varying risk levels of sexual abusers, and to further advocate for the differential treatment planning of those offenders, driven by their varying levels of risk, and other case specific needs. Since that time Scott has continued to conduct risk assessments, with both juvenile and adult sexual abusers, and to provide treatment services for both. To date he has completed over 1,000 psychosexual risk assessments on juvenile and adult sexual abusers. In the Fall of 2016 at the ATSA (Association for The Treatment of Sexual Abusers) National Conference, Scott was selected by the ATSA Executive Board as an ATSA Fellow; a recognition bestowed upon ATSA members who have demonstrated allegiance to their profession and a strong commitment to the ongoing work of the Association

Thomas Romero, MC, LPC

Tom has been working in the field of sex offender treatment since the mid 1990's, first in a custodial role at the Arizona Community Protection & Treatment Center (Civil Commitment Program) and since 2001 as a Licensed Professional Counselor (LPC) in a group practice at Family Transitions. While a portion of his work has involved working with survivors and secondary victims of sexual abuse, the vast majority of his focus has been on treating adult male offenders, primarily under contract with probation departments around the state. In addition to treatment services Mr. Romero provides training to clinical and probation staff in the concepts of RNR (Risk, Needs, Responsivity), sex offender treatment and dynamic risk assessment. He provides clinical supervision for graduate level interns from local universities and for those seeking licensure as LPC's. He strives to stay abreast of evidenced-based concepts as it relates to testing, assessment and treatment and is a clinical member of the Association for the Treatment of Sexual Abusers (ATSA).

Lt. Anthony Bennett

Lieutenant Anthony Bennett has been a Texas Peace Officer for the past twenty-six years and has worked within the Texas Department of Public Safety-Criminal Investigations Division since 2002. In 2015, he became a license examiner with the Texas DPS Polygraph Unit. In this capacity, he has conducted over 1200 polygraph examinations and has interviewed suspects in numerous types of investigations related to homicide, robbery, child sexual abuse and arson. Lieutenant Bennett has instructed polygraph topics at various conference throughout North America and with the Texas DPS Law Enforcement Polygraph School. Lieutenant Bennett is also a board of director for the Texas Association of Law Enforcement Polygraph Investigators

S.A. Roy Basham

Roy Basham is a Special Agent with the Texas Department of Public Safety, Criminal Investigations Division and has been employed with Texas DPS for over twenty years. In 2018, Roy completed the Texas DPS Polygraph school and became a licensed polygraph examiner. During this period, Roy has conducted over 400 criminal, tactical and pre-employment polygraph examinations. Roy has received criminal confessions on Homicides, Sexual Assaults of Children, Human Trafficking, Drug Trafficking Possession and/or Production of Child Pornography and more. Roy is a current member of AAPP (American Association of Police Polygraphist) and TALEPI (Texas Association of Law Enforcement Polygraph Investigators).
